

**THE ON THE ROCKS WINTER YOUR WAY SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The On The Rocks Winter Your Way Sweepstakes ("Sweepstakes") is sponsored by Jim Beam Brands, Co. ("Sponsor"), 222 West Merchandise Mart Plaza, Chicago, IL 60654, and is administered by Clarus Commerce LLC, ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48076.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 4, 2023 at 12:00 PM Eastern Time ("ET") and ends on March 31, 2023 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia, who are at least twenty-one (21) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Employees, agents and officers of alcohol beverage retailers and distributors and their immediate family members and all other individuals/entities associated with this Sweepstakes are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit [www.otrsweeps.com](http://www.otrsweeps.com) ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Entrant must also select the prize pool he/she wants to be entered into (each a "Prize Pool"). There are three (3) Prize Pools as follows: Ski ("Ski Pool"), Golf ("Golf Pool"), and Beach ("Beach Pool"). Upon the successful submission of the registration information, an entrant will receive one (1) entry into the applicable Prize Pool he/she selected and one (1) entry into the pool for his/her state of residence if entrant is a resident of Arizona, Arkansas, Colorado, Florida, Louisiana, Michigan, Nevada, New Mexico, New York, North Carolina, Virginia, or Washington (each a "State Pool").

**Entry Limit:** There is a limit of one (1) Prize Pool entry and one (1) State Pool entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on January 4, 2023 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

**NOTE:** During the Sweepstakes Period, an entrant may receive a link to the Website by scanning the QR code on select Sweepstakes print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

**IMPORTANT:** MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THESE SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER'S PRICING PLANS. MOBILE ENTRY IS NOT REQUIRED TO ENTER OR WIN A PRIZE IN THIS SWEEPSTAKES.

**4. RANDOM DRAWING:** On or around April 3, 2023, the Administrator will randomly select one (1) potential winner from all eligible entries received for each State Pool, for a total of twelve (12) potential State Pool winners and twenty (20) potential grand prize winners from each Prize Pool, fifty (50) potential first prize winners from each Prize Pool, and one hundred (100) potential second prize winners from each Prize Pool. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZE, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. State Pool Prizes (12 total; 1 per State Pool):** Each State Pool prize is a bundle that includes a cooler backpack, a pair of wool socks, a beanie, a golf umbrella, a golf hat, a sleeve of golf balls, a cooler tote, a speaker, and a bucket hat (each a “State Pool Prize”). No more than twelve (12) State Pool Prizes will be available in the Sweepstakes, one (1) per State Pool. The ARV of each State Pool Prize is \$167.50.

**B. Prize Pool Prizes:** The Prize Pool prizes are as follows:

**i. Ski Pool:**

**1. Ski Pool Grand Prizes (20):** Each Ski Pool grand prize is a branded cooler backpack (each a “Ski Pool Grand Prize”). No more than twenty (20) Ski Pool Grand Prizes will be available in the Sweepstakes. The ARV of each Ski Pool Grand Prize is \$31.

**2. Ski Pool First Prizes (50):** Each Golf Pool first prize is a pair of branded wool socks (each a “Ski Pool First Prize”). No more than fifty (50) Ski Pool First Prizes will be available in the Sweepstakes. The ARV of each Ski Pool First Prize is \$19.

**3. Ski Pool Second Prizes (100):** Each Ski Pool second prize is a branded beanie (each a “Ski Pool Second Prize”). No more than one hundred (100) Ski Pool Second Prizes will be available in the Sweepstakes. The ARV of each Ski Pool Second Prize is \$5.

**ii. Golf Pool:**

**1. Golf Pool Grand Prizes (20):** Each Golf Pool grand prize is a branded golf umbrella (each a “Golf Pool Grand Prize”). No more than twenty (20) Golf Pool Grand Prizes will be available in the Sweepstakes. The ARV of each Golf Pool Grand Prize is \$38.

2. **Golf Pool First Prizes (50):** Each Golf Pool first prize is branded golf hat (each a “Golf Pool First Prize”). No more than fifty (50) Golf Pool First Prizes will be available in the Sweepstakes. The ARV of each Golf Pool First Prize is \$17.50.
3. **Golf Pool Second Prizes (100):** Each Golf Pool second prize is a sleeve of branded golf balls (each a “Golf Pool Second Prize”). No more than one hundred (100) Golf Pool Second Prizes will be available in the Sweepstakes. The ARV of each Golf Pool Second Prize is \$6.

iii. **Beach Pool:**

1. **Beach Pool Grand Prizes (20):** Each Beach Pool grand prize is a branded cooler tote (each a “Beach Pool Grand Prize”). No more than twenty (20) Beach Pool Grand Prizes will be available in the Sweepstakes. The ARV of each Beach Pool Grand Prize is \$30.
2. **Beach Pool First Prizes (50):** Each Beach Pool first prize is a branded speaker (each a “Beach Pool First Prize”). No more than fifty (50) Beach Pool First Prizes will be available in the Sweepstakes. The ARV of each Beach Pool First Prize is \$14.95.
3. **Beach Pool Second Prizes (100):** Each Beach Pool second prize is a branded beanie (each a “Beach Pool Second Prize”). No more than one hundred (100) Beach Pool Second Prizes will be available in the Sweepstakes. The ARV of each Beach Pool Second Prize is \$6.

**C. Odds of Winning:** The odds of winning a State Pool Prize depend on the number of eligible Sweepstakes entries received for each State Pool during the Sweepstakes Period and the odds of winning a Prize Pool Prize depend on the number of eligible entries received for each Prize Pool during the Sweepstakes Period.

**D. General Conditions:** There is a limit of one (1) prize per person. In no event will more than the stated number of prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

**6. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and compliance with these Official Rules. After each random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration. The potential winners of a prize with an ARV of \$25 or more will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or his/her prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor’s sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner’s right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the prize may be forfeited. If a prize is forfeited, the respective prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a

good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, prizes will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry. Any portion of a prize not accepted by winner will be forfeited. The winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The prizes will only be awarded to verified winners.

Sponsor will attempt to notify the potential winners as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any unanswered or undeliverable winner notifications.

(g) lost, late, stolen, misdirected, damaged or destroyed prize (or any element thereof); or (h) the negligence or willful misconduct by entrant.

If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

DISPUTES:** THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
